

When a business registers as a formal entity with state authorities, the entity is periodically required to complete certain compliance activities which are a prerequisite for maintaining active (good) business standing. The rules are different for each type of business entity and vary from state to state.

This chart details state annual reporting due dates for five business entity types.
